6. ACCIDENTAL RELEASE MEASURES

7. HANDLING, STORAGE & SPILLAGE OR LEAK PROCEDURES

Precautions to be Taken in Handling: Keep away from heat, sparks and flame. Keep container closed. Safety goggles with full-face shield and eyewash recommended. USDA-accepted Nitrile (CFR-20) or Neoprene Rubber (CFR-21) recommended. Wear appropriate clothing to prevent repeated or prolonged skin contact. Use only with adequate mechanical exhaust ventilation. In accordance with good industrial practices, handle with due care and avoid personal contact.

Precautions to be Taken in Storage: Product should be stored in a dry place with temperatures above 30° F. Partially used containers should be resealed between uses for maximum storage stability.

Spill or Leak Procedures: Sweep up spilled material and discard into proper waste containers for disposal. Dispose of material in accordance with all federal, state and local regulations in an approved waste disposal facility.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION
